<b>New Member</b>	Companies & organizations in Japan who have not been a member at AHK Japan for at least three years are eligible for this category. The New Member status is valid until the end of the year of application.	50,000	
<b>Non-Resident Member</b>	Companies without a legal entity in Japan are eligible for the Non-Resident Member status.	70,000	
<b>Non-Profit Member</b>	Non-profit organizations and (local) government are eligible to become a Non-Profit Member.	50,000	
<b>Full Member</b>	All companies and organizations regardless of nationality and/or legal entity can apply for a Full Membership at AHK Japan. Only Full Members have voting rights at the Annual General Meeting and can become a member of the board of AHK Japan. The annual fee for Full Members is based on individual revenue for manufacturers and number of employees for service providers.
